This project involves the construction of the Gippsland Agricultural Recovery and Resilience Center. (The Centre) The centre will be a multi-purpose community facility providing the agricultural community with a place to gather, learn and apply approaches to bushfire recovery and climate mitigation. These benefits will assist the agricultural community to recover from the impact of the Black Summer bushfires, while increasing the knowledge and resilience of farmers to prepare for, predict, and manage future bushfire events. The center will be sited at the nexus of the Gippsland Research Farm, the Bairnsdale Airport, and the East Gippsland Field Days site.

Detailed project description and key activities

The Centre has been designed as a cost-effective and simple structure, and will include:

- A multipurpose hall
- Shaded external hard stand exhibition space
- A hot desk co-working and office space
- A tutorial room and 'Digital Ag Centre'

• Amenities including toilets, kitchen, and reception area In addition to the immediate needs of the agricultural community, components of the building design have been designed to meet the requirements for use by emergency services and the military via the Bairnsdale Aerodrome. This was identified as an essential need during the Black Summer bushfire events due to the limited capacity and overcrowding of the airport.

The Gippsland Agricultural Group (GAaG) project development team, including key partner East Gippsland Shire Council, have conducted extensive community consultation, and have contracted A1 Design in Bairnsdale to provide an initial concept design of the Centre. Quotes have now been secured from experienced local contractors, with construction able to commence as soon a funding has been secured.

The centre will be constructed as an industrial shed, on a concrete slab base. The external walls and ceiling will consist of steel, with heating and cooling supplied via an efficient reverse cycle heating/air conditioning system. Internal walls will be constructed with timber and plasterboard fixings.

Construction of the Centre includes the following key activities:

• The chosen local contractors will order materials as soon as possible to lock in prices and minimise the cost of materials.

• GAaG will work with East Gippsland Shire Council to secure all relevant permits.

• Detailed plans for the centre's internal layout will be finalised in consultation with the key user groups.

• Details of the computers and other equipment in the 'Digital Ag Centre' will be finalised with project partner Telstra.

• Construction of the Centre will be undertaken by experienced local contractors, with project management by East Gippsland Shire Council and GAaG.

- The finished centre will be handed over to GAaG.
- The centre will be officially opened, and a community celebration will be held.

The GAgG committee recognises the major benefits which this project will bring to the agricultural community of Gippsland. As a measure of the group's commitment, it is contributing \$29,320 to cover project management costs, a further \$10,000 to cover the project reporting costs, and an additional \$40,000 towards the project as a whole, a total contribution of \$74,320. These funds have been raised by the committee through community fundraising activities.

Project outcomes

Following the Black Summer bushfires, impacted individuals and families in local geographic areas naturally gathered at facilities such as community halls. At these facilities, householders were able to access support, register for assistance from government and non-profit organisations, obtain vital rebuilding information, and access mental health supports.

The Gippsland agricultural community was also heavily impacted by the Black Summer bushfires, and just like impacted local communities, needed a central point to come together to share information, register for assistance, and access support.

Unfortunately, without a central gathering point for farmers to gather, obtain financial and practical assistance, and access donations of supplies such as fodder, many members of the agricultural community flew 'under the radar' and were unaware of the support and assistance available to them.

Currently GAgG are aware of farmers who were unable to access a wide range of supports, including practical support such as donated materials and labour, as well as mental health supports. This has resulted in several members of the agricultural community experiencing severe mental health impacts, financial issues, and family and marriage stresses.

In response, GAgG have developed plans for the Center. This facility will provide the essential central point for the agricultural community in times of need such as bushfire. Due to the fact that the agricultural community will need many years to recover from the Black Summer bushfires, the centre will also work to educate farmers about the latest research regarding returning fire-impacted agricultural land to full production and will serve as a vital link for bushfire-impacted members of the farming community to access mental health information and support. The centre has been designed with the support of key partners East Gippsland Shire Council, with an additional aim of specifically providing a vital overflow location for the adjoining Bairnsdale Airport during future bushfires.

The following are examples of the way in which the Gippsland Agricultural Centre will assist the agricultural community as well as the wider community, in the aftermath of the Black Summer bushfires: SHORT TERM

Farmers are still working hard to return fire-impacted agricultural land to full production, as well as replace stock and equipment. The Centre will

provide a central point for the farming community to access the latest research on the restoration of fire-impacted pastures and land, as well as rebuilding stock numbers and genetics.

Vitally, the centre will also be a trusted location for the agricultural community to access mental health supports. Research has shown that it is in the second and following years after a natural disaster such as bushfire that mental health impacts become most apparent.

MEDIUM TERM

In the medium term, the center will be a hub for farmers to access coordinated service delivery that is tailored to the unique challenges faced when managing agricultural operations during natural disasters such as bushfires and drought.

This will also be a time when the centre begins programs working with students from local primary, secondary and tertiary institutions to ensure that the next generation of farmers have the resources and knowledge to efficiently manage agricultural production while navigating the pressures of climate change and increased demand for agricultural products.

LONG TERM

In the long term the center will be the hub of a thriving agricultural precinct that connects several other agricultural functions including the East Gippsland Field Days, the Gippsland Research Farm, and a community-owned agricultural training facility. This will enable agricultural producers in the region to prepare for and respond to bushfires and other natural disasters and build a resilient and well-connected agricultural community and industry in the region.

During future bushfires and other natural disasters, the Centre will facilitate the overflow operations of the Bairnsdale Airport to allow additional facilities for services including the Australian Army and Royal Flying Doctor Service.

The bushfires of 2019/2020 had devastating impacts on East Gippsland farmers and the agricultural industry. After four years of the harshest drought in 400 years, conditions in the region were extremely dry. This compounded the impacts and intensity of the fires and resulted in the

following direct impacts to 979 properties in East and central Gippsland:

21 per cent of East Gippsland's agricultural land was severely impacted by the fires.

\$31.3 million of fencing was destroyed

\$33.7 million dollars of key infrastructure (dairy, machinery, hay sheds, etc) was burned

\$25.6 million of field crops was destroyed

869 livestock were killed

30 family farmhouses were destroyed

10 woolsheds, 55 haysheds, 88 machinery sheds were destroyed. Immediately following the fires, GAgG worked tirelessly to gather information on affected producers and provide information and assistance about the practical, financial, and emotional supports available to the region's producers. During this time a central location to coordinate these response and relief activities was desperately needed. This lack of a central base made it difficult to co-ordinate, triage, and deliver timely and effective immediate and ongoing recovery support for fire impacted farmers. Feed, fodder, and veterinary supplies rolled into the region, but the co-ordination of the distribution was challenging for the various industry, support and producer-led groups participating in the relief and recovery effort. This resulted in the duplication of many services and left gaps in recovery support and service delivery in others. The agricultural community will take many years to recover fully. Statewide recovery of burnt pastures will continue well into 2022, with resulting impacts on livestock production in these areas. Production losses from burnt pastures are estimated to be \$48 million in 2021 and \$18 million in 2022. Victorian agriculture is expected to lose \$400 million through 2020 and 2022 in lost assets and agricultural production as a direct result of the bushfires.

In the aftermath of the fires a significant amount of work remains to develop and deliver learnings about bushfire recovery from our pasture trail work to the agricultural community. Farmers are desperately seeking guidance in the best approaches to successfully re-establish fire affected pasture, based on local climatic conditions and soil parameters. The Centre will better enable learning and sharing of information to enable the region's farming communities to recover faster and be better prepared for future bushfires and other disasters. By providing a central gathering place intersecting with research farm trials, the Centre will greatly assist in this endeavour over the next 3-5 years and beyond. The Centre will facilitate recovery from the Black Summer bushfires and the development of resilience following future natural disasters in the agricultural community by:

SOCIAL RECOVERY AND RESILIENCE NEEDS

Combating social isolation and building a community support network for one of the nation's most at-risk groups of suicide.

Providing a meeting place for not-for-profit producer groups such as Landcare, Topsoils, East Gippsland Women in Agriculture etc ECONOMIC RECOVERY AND RESILIENCE NEEDS

Being a place to educate, train and upskill our region's agricultural workforce to attract and retain talent to sustain our small communities Presenting cutting-edge technology to inform regionally relevant adaptations and innovations to be implemented to boost productivity and increase resilience to future drought and bushfire events Embracing digital transformation through education and promotion of data collection and early warning systems which track and report data

relevant to our region, to inform adaption and mitigation of risks before they materialize.

RECOVERY AND RESILIENCE OF THE BUILT ENVIRONMENT Engaging producers in learning and adaptation toward increasing production as well as mapping and managing risks in their systems During our community consultation, more than 15 user groups have identified a need and listed extensive uses for the facility across the year. All these activities will assist the agricultural community to recover from the Black Summer bushfires, including:

Weekly education classes that incorporate online learning from universities with field work on the research farm

TAFE classes for short and long courses in agriculture

Classes and engagement days from primary and secondary educational institutions

Short skills and competency-based courses such as shearing schools and chemical users permit classes

Quarterly Field Days to present and share research and trial work Annual Conferences, East Gippsland Women in Agriculture, and Gippsland Red Meat.

This project will be managed by GAgG in partnership with East Gippsland Shire Council and will be constructed by experienced local contractors. Since the Black Summer fires the concept and business case for this proposed Centre has been developed following significant collaboration with bodies including East Gippsland Shire Council, community bushfire recovery committees, peak industry bodies (such as MLA and AWI), the Victorian Drought Hub, The National Recovery and Resilience Agency, over 15 community agricultural related organisations, and local secondary and tertiary education providers including Federation University.

Every element of the project has been accurately costed to December 2021 with assurances that our suppliers have the capacity and time in their work schedule to promptly commence construction as soon as funding is secured. A detailed project plan has been developed with a project control group consisting of:

• Trevor Caithness – GAgG CEO and owner operator of a large business in regional Victoria.

• Ken White – GAgG Treasurer and chartered accountant, with extensive experience on capital works project delivery, reporting and compliance.

• Jen Smith – General Manager GAgG – lead person on project funding application and on the ground project delivery, with over 15 years' experience in project co-ordination in both the private and government sectors.

• <u>s22</u> – East Gippsland Shire Council General Manager Assets and Environment.

• s22 – East Gippsland Shire Council Bushfire Recovery

Manager.

• **s22** - Construction Manager - extensive experience in managing major construction projects including Bairnsdale TAFE Education and Learning Facility as well as several other large projects.

• s22 – Project Administrator – highly experienced in administration, including record keeping, data processing, and ensuring administrative goals and deadlines are met.

• s22 - Project Communications and Engagement Manager – experienced commercial journalism and social media content writer, who will ensure that this project is well communicated at a local, state and commonwealth level.

The contractors selected to provide quotes for this job have been chosen based on their capacity to deliver the project well within the project timing guidelines. The lead contractor Eastern Victorian Construction Group has 30 years of experience in delivering similar projects.

GAgG have approached the procurement of costings and quotations for this project with a specific focus on both supporting fire-affected construction businesses and contractors and maximising the capacity for the project to be delivered in a timely and cost-efficient manner. Some examples of previous GAgG group project management includes:

• Partnering with Agriculture Victoria on the redevelopment of the former Southern Farming Systems agricultural trial site of approximately 10 hectares into a showpiece 117 Hectare dedicated dryland research farm, which was the first of its kind in Eastern Victoria. This project was delivered early and on budget, with all milestones achieved to the satisfaction of our funding partner.

• Collaborative work with East Gippsland Shire Council and Agriculture Victoria to rollout an extensive Soil Moisture Probe program throughout our member base in East Gippsland.
